

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

Invesco NASDAQ-100 ESG UCITS ETF (the "**Fund**")

A sub-fund of Invesco Markets II plc (the "**Umbrella Fund**")

EUR Hdg Acc (ISIN: IE000JSJOR00) (the "**Share Class**")

This Fund is authorised in Ireland.

PRIP Manufacturer: The Fund is managed by Invesco Investment Management Limited, part of the Invesco Group. Invesco Investment Management Limited is authorised in Ireland and regulated by the Central Bank of Ireland. The Central Bank of Ireland is responsible for supervising Invesco Investment Management Limited in relation to this Key Information Document.

What is this product?

Type

The Fund is an Exchange-Traded Fund ("**ETF**"), a sub-fund of the Umbrella Fund which is incorporated in Ireland and authorised by the Central Bank of Ireland as a limited liability umbrella type open ended UCITS investment company with variable capital and segregated liability between its sub-funds.

Term

The Fund has no maturity date. The Fund may be terminated unilaterally by the directors of the Umbrella Fund and there are circumstances in which the Fund can be terminated automatically, as further described in the prospectus.

Objectives

Investment objective:

The investment objective of the Fund is to achieve the net total return performance of the NASDAQ- 100® ESG Index (the "**Index**"), less fees, expenses and transaction costs.

Investment approach:

The Fund is a passively managed ETF.

To achieve the investment objective, the Fund will, as far as possible and practicable, hold all the shares in the Index in their respective weightings.

The Fund may use derivative instruments for the purposes of managing risk, reducing costs, generating additional capital or income.

The Fund may engage in securities lending, whereby 90% of the revenues arising from securities lending will be returned to the Fund and 10% of the revenues will be retained by the securities lending agent. The Fund may be exposed to the risk of the borrower defaulting on its obligation to return the securities at the end of the loan period and of being unable to sell the collateral provided to it if the borrower defaults.

The Fund is an Article 8 Fund (it promotes environmental and/or social characteristics) for the purposes of Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability-related disclosures in the financial services sector ("**SFDR**").

The Fund's base currency is USD.

The Share Class currency is EUR. To minimise exposure to fluctuations in the exchange rate between the Fund's base currency and the Share Class currency, the Share Class enters into foreign exchange transactions (typically FX forwards). Currency hedging between the base currency of the Fund and the currency of the share class may not completely eliminate the currency risk between those two currencies and may affect the performance of the share class.

The Index:

The Index is designed to reflect the performance of the companies that meet specific ESG criteria in the NASDAQ-100 Index® (the "**Parent Index**").

Companies are evaluated and weighted on the basis of their business activities, controversies and ESG risk ratings. The Index is constructed by using the index provider's exclusionary criteria (as defined by the index provider using Sustainalytics data) to exclude from the Parent Index securities of issuers that: 1) are involved in any of the following business activities: adult entertainment, alcohol, arctic oil & gas exploration, cannabis, controversial weapons, gambling, military weapons, nuclear power, oil & gaseous fuels, power generation from sources with high greenhouse gas intensity, oil sands, riot control, shale energy, small arms, thermal (including hard coal and lignite) coal, and tobacco, 2) are from issuers with a controversy level higher than 4; 3) are from issuers which

do not have a Sustainalytics ESG risk rating score or have a Sustainalytics ESG risk rating score that is higher than or equal to 40; and 4) are from issuers deemed not to comply with the principles of the United Nations Global Compact.

Involvement and revenue thresholds are defined by the Index provider. Further information in relation to any revenue thresholds and controversy scoring criteria, can be obtained from the Index provider's website. Each of the eligible component securities is then assigned a weighting factor based on its respective Sustainalytics ESG risk rating, which is applied to re-weight the eligible securities using their market value in the Parent Index to construct the weighting of the Index. The re-weighted eligible component securities are then subject to a set of capping constraints to ensure diversification.

The Index is rebalanced on a quarterly basis.

Investors should note that the Index is the intellectual property of the Index provider. The Fund is not sponsored or endorsed by the Index provider and a full disclaimer can be found in the Fund's supplement.

Dividend Policy:

This Share Class does not pay you income, but instead reinvests it to grow your capital, in line with its stated objectives.

Redemption and Dealing of Shares:

The Fund's shares are listed on one or more Stock Exchange(s). Investors can buy or sell shares daily through an intermediary directly or on Stock Exchange(s) on which the shares are traded. In exceptional circumstances investors will be permitted to redeem their shares directly from the Umbrella Fund in accordance with the redemption procedures set out in the prospectus, subject to any applicable laws and relevant charges.

Intended Retail Investor

The Fund is intended for investors aiming for long term capital growth, who may not have specific financial expertise but are able to make an informed investment decision based on this document, the supplement, and the prospectus, have a risk appetite consistent with the risk indicator displayed below and understand that there is no capital guarantee or protection (100% of capital is at risk).

The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class.

This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the ability for you to receive a positive return on your investment.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency from your local currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance Scenarios

What happens if Invesco Investment Management Limited is unable to pay out?

The assets of the Fund are segregated from those of Invesco Investment Management Limited. In addition, the Depositary of the Umbrella Fund, is responsible for the safekeeping of the assets of the Fund. To that effect, if Invesco Investment Management Limited defaults, there will be no direct financial impact on the Fund. In addition, the assets of the Fund shall be segregated from the Depositary's assets, which may limit the risk for the Fund suffering some loss in case of default by the Depositary. As a shareholder in the Fund, there is no compensation or guarantee scheme in place.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year, you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product has no required minimum holding period. The recommended holding period has been selected due to its investment strategy and because it is designed for a long term investment horizon.

You can sell your shares in the Share Class during this period or hold the investment longer. If you sell some or all of your investment before 5 years, your investment will be less likely to achieve its objectives; however, you will not incur any additional costs by doing so.
