Notwithstanding the ex-dividend dates and record dates disclosed in the Prospectus, Hong Kong investors should refer to the Hong Kong distribution announcements for the ex-dividend dates, record dates and payment dates applicable to investors holding Shares listed on the SEHK. Due to difference in time zone and settlement cycle between the U.S. market and the Hong Kong market, the amount of dividend payment will not yet be announced on the Hong Kong ex-dividend date[#]. The Sponsor will inform Hong Kong investors of the amount of dividend payment as soon as reasonably practicable after the day the Trust declares dividend, which is usually the business day following the Hong Kong ex-

dividend date. Hong Kong investors should exercise caution when trading Shares on the SEHK on Hong Kong ex-dividend dates since any discount or premium in the trading price of the Shares on the SEHK relative to the NAV per Share may widen as a result of the upcoming dividend payment, the amount of which is not yet announced.

Investors who purchase Shares on the SEHK on or after Hong Kong ex-dividend date will not be entitled to the upcoming dividend payment. Investors will only receive dividend payment if they purchase Shares on the SEHK before the Hong Kong ex-dividend date.

Shares in all trading counters will receive distributions in the base currency (USD) only.
