Invesco Monthly Investment Plan 景順月供投資計劃 TERMS AND CONDITIONS 條款及條件

This document should be distributed in conjunction with the prospectus in which the participants intend to invest. Terms used herein and not otherwise defined shall have the meaning ascribed to them in the prospectus. 本文件應與參加者有意投資的基金章程一併派發。本文件所用且並無另有界定的詞彙，均與基金章程內所載者具有相同涵義。

Minimum Investment 最低投資額

Initial Investment 首次投資額：

An initial investment of HK\$5,000 for each fund is required in order to participate in the Invesco Monthly Investment Plan ("the Initial Investment") 參與景順月供投資計劃的首次投資額為每項基金 5,000 港元（「首次投資額」）。

Subsequent Investment 其後投資額：

Following the initial investment, further regular contributions to the Invesco Monthly Investment Plan must be at least HKD\$2,000 per month into each fund. 作出首次投資後，景順月供投資計劃的進一步定期供款最少為每項基金每月 2,000 港元。

Funds Available under the Invesco Monthly Investment Plan 景順月供投資計劃下可供認購的基金

Any sub-fund of Invesco Funds (the "SICAV") that is authorized by the Securities and Futures Commission for distribution to the public in Hong Kong.

獲證券及期貨事務監察委員會認可因而可向香港公眾人士提呈發售的任何景順盧森堡基金系列（「SICAV」）附屬基金。

Process for Making Monthly Contributions 作出每月供款的程序

In order to participate in the Invesco Monthly Investment Plan, you are required to complete the following documents: 如欲參與景順月供投資計劃，閣下必須填寫下列文件：

- Invesco Monthly Investment Plan Subscription Form (including the Direct Debit Authorisation Form)
景順月供投資計劃認購表格（包括直接付款授權書）
- Invesco Application Form (you must complete this Form if you have not previously invested in Invesco Funds)
景順申請表格（若申請人之前並未投資於景順基金，則必須填寫該表格）

Once these documents have been completed and processed, your ongoing monthly contributions to Invesco Monthly Investment Plan will be made by direct debit from your bank account. It may take 4 to 8 weeks to set up the direct debit arrangement. 此等文件一經填寫及處理妥當，申請人持續向景順月供投資計劃作出的每月供款將會直接從申請人的銀行戶口扣除。設立直接付款安排需時四至八星期。

Monthly contributions must be made in Hong Kong Dollars (HK\$) and by way of direct debit from your bank account. Payments by cheque will not be accepted for any payment other than for the payment of the Initial Investment. 每月供款必須以港元 (HK\$) 支付，並會直接從申請人的銀行戶口扣除。除支付首次投資額外，支票付款恕不接納。

Upon successful set up of the direct debit arrangement, your bank account will normally be debited on the first business day after the debit date. A business day is any day (other than a Saturday) on which banks are open for normal banking business. A dealing day in this context means a business day in Luxembourg. 成功設立直接付款安排後，申請人的銀行戶口一般會在每月首個營業日扣款。景順將於扣款日期後的第三個營業日將申請人的供款投資於一項或多項指定基金。營業日指銀行開門經營一般銀行業務的任何日子（星期六除外）。就此，交易日則指盧森堡的營業日。

Should Invesco receive notification from its selection bank of a failure to receive a direct debit remittance from your account, Invesco will cancel any orders placed on your behalf in the relevant fund(s). Invesco reserves the right to hold you liable for all losses borne by the fund and/or Invesco in cancelling the order. 若景順接獲其選定銀行通知無法從申請人的戶口收取直接扣款，景順會將已代申請人就有關基金發出的指令註銷。景順保留權利，要求申請人就該基金及／或景順因註銷該指令而蒙受的一切損失承擔責任。

You are reminded to ensure that sufficient funds are available in your designated account in order to complete the debit of your monthly contribution to the Invesco Monthly Investment Plan. 申請人務請確保其指定戶口有足夠款項，以便扣除其向景順月供投資計劃作出的每月供款。

Invesco reserves the right to terminate your participation in the event of two successive failed direct debits or three direct debit failures within a twelve month period. 景順保留權利，若連續兩次未能直接扣款，又或於 12 個月期間內有三次未能直接扣款，可終止申請人的參與資格。

Loyalty Discount 長期惠顧折扣

Upon joining the Invesco Monthly Investment Plan, you will be offered a loyalty discount. However, if you decide to terminate your Monthly Investment Plan within 12 months of your first contribution to the plan, such discount will be revoked and you will have to pay the difference. 加入景順月供投資計劃時，您將獲給予長期惠顧折扣。然而，若您決定在首次向計劃供款後 12 個月內終止月供投資計劃，該項折扣將被撤銷，而您必須補回差價。

How to Change your Monthly Contributions 如何更改每月供款

If you wish to change (either increase or decrease) the amount of your monthly contribution, you must provide Invesco with at least two weeks' written notice of such change, stating the new monthly contribution figure. 若您有意更改（調高或調低）每月供款額，須就更改向景順發出最少兩星期的書面通知，列明新訂每月供款額。

If you wish to increase the amount of your monthly contribution above the limit for each payment, then you must complete a new Direct Debit Authorisation Form. In this case a longer time may be required to effect the change. 若您有意將每月供款額增至高於每次付款上限的水平，則須填寫新的直接付款授權書。在此情況下，處理有關更改需時較長。

You are reminded that for continued participation in the Invesco Monthly Investment Plan, your monthly subscription amount should not fall below the minimum monthly contribution of HK\$2,000. 敬請留意，如欲繼續參與景順月供投資計劃，您的每月認購額不得低於每月最低供款額 2,000 港元。

How to Redirect Your Monthly Contributions 如何重新安排每月供款

If you wish to redirect your future monthly distributions to a different fund(s), you may do so by providing Invesco with at least two weeks' written notice of such change, clearly setting out the revised list of fund(s) you have selected. If you are not an existing holder of the selected fund, please be reminded of an initial investment of HK\$ 5,000 for each fund. Following receipt by Invesco of the notice, Invesco will redirect your future monthly contributions commencing with the next scheduled monthly contribution and investments. 如欲重新安排日後的每月供款，以投資於不同的基金，則請就更改而向景順發出最少兩星期的書面通知，清楚列明您所選定的經修訂基金名單。如非屬選定基金的現有持有人，務請留意每項基金的首次投資額為 5,000 港元。景順接獲有關通知後，將由下一筆預定每月供款及投資開始重新安排您的日後每月供款。

How to Switch Your Investments 如何轉換投資

You may switch all or part of your holdings in one fund to another fund by completing a Switching Form (or any other document required by Invesco). Switching is normally subject to a switching charge. Full details of the switching procedures and charge can be found in the prospectus. 如欲將所持有的一項基金的全部或部分投資轉移至另一項基金，可填妥轉換表格（或景順所規定的任何其他文件）。轉換一般須收取轉換費。有關轉換程序及費用的詳情載於基金章程。

You are also reminded that future monthly contributions will continue to be invested in the original funds unless we have received instructions to the contrary in accordance with the procedures set out above under "How to Redirect Your Monthly Contributions". 敬請留意，除非景順已接獲您根據「如何重新安排日後投資」一節所述程序而作出的更新指示，否則日後的每月供款將繼續投資於原有基金。

How to Redeem Your Investments 如何贖回投資

If you wish to redeem your investments in Invesco Funds, you may do so by submitting a Redemption Form (or any other document required by Invesco). Full details of redemption procedures can be obtained from the prospectus. Please note that redemption payments will not be paid by way of cheques. 如欲贖回在景順基金的投資，可填妥贖回表格（或景順所規定的任何其他文件）。有關贖回程序及費用的詳情載於基金章程。敬請留意，贖回款項不會以支票方式支付。

You are reminded that future monthly contributions will continue to be deducted from your designated account unless you have provided Invesco with instructions for termination of your Invesco Monthly Investment Plan in accordance with the procedures described below. 敬請留意，除非您已遵照下文所載程序向景順發出終止景順月供投資計劃的指示，否則景順將繼續從您的指定戶口扣除日後的每月供款。

How to terminate the Invesco Monthly Investment Plan 如何終止景順月供投資計劃

If you wish to stop contributing to the Invesco Monthly Investment Plan, you may do so by sending one month written notice to Invesco. Following receipt of such notice Invesco will stop direct debit collections from your account. 如欲停止向景順月供投資計劃供款，可向景順發出一個月書面通知。景順將於接獲該通知後停止從您的戶口收取直接付款。

Following termination of your Invesco Monthly Investment Plan, if you wish to redeem your holdings in the fund, you may do so in accordance with the procedures set out under the "How to Redeem Your Investments" Section. 如欲於終止景順月供投資計劃後贖回所持基金投資，可按「如何贖回投資」一節所述程序辦理。

Investor Information 投資者的資料

Investor's personal details, identity proof, address proof and/or relevant documents may be transferred to the Registrar & Transfer Agent, and/or the Data Processing Agent (and/or authorized agents appointed by the SICAV, the Registrar and Transfer Agent or the Data Processing Agent), and to auditors, regulators, tax authorities, Depository, the Sub-Distributors or other agents or delegates of the SICAV/Management Company which may be a third party organization and is not part of Invesco Group for anti-money laundering checking, processing data and/or instructions. Contract notes will be issued for direct debit subscriptions to Invesco Funds. Should there be any materials changes to the terms of the Invesco Monthly Investment Plan as set out in this document and/or the Application Form, Invesco will provide you with at least one month notice if such change(s). 本文件及／或申請表格載列的景順月投資計劃條款如有任何重大更改，景順將就有關更改向您發出最少一個月通知。

Risk Disclosure Statement 風險披露聲明

The prices of shares/units fluctuate, sometimes dramatically. The prices of shares/units may move up or down, and may become valueless. It is as likely that losses will be incurred rather than profit made as a result of buying and selling securities. Funds may invest in emerging markets or single countries or industry sectors. The investment focus of such funds might give rise to increased risk over more diversified funds. Also, there are special risks involved with investment in hedge funds/absolute return funds. Important Note for Investors in Fixed Distribution Share Classes 固定派息股份類別投資者須知

The generation of income has a higher priority than capital growth in the context of Fixed Distribution Share Classes, and as such a portion or all of the fees and expenses payable by and attributable to the fixed distribution Share classes, together with miscellaneous expenses set out in the prospectus may be paid from the capital of such Classes where necessary in order to ensure there is sufficient income to meet the fixed distribution payments. Investors should note that the charging of fees and expenses to capital in this manner though will result in income being increase for distribution, will result in capital erosion and therefore constrain future capital growth for such Shares Classes, together with the likelihood that the value of future returns would be diminished. Investors should also note that the payment of fees and expenses out of capital represents a return or withdrawal of part of the amount they originally invested or from any capital gains attributable to the original investment. Such payment of fees and expenses may reduce the net asset value per Share of the relevant fixed distribution share class immediately after the monthly distribution date.
