- (1) Definition of terms 用詞定義

 - (c) "Original Trustee" (also known as "transferor trustee" in the Mandatory Provident Fund Schemes (General) Regulation ("the Regulation")) - the trustee of a scheme from which your benefits are to be transferred. 「原信託人」(在《強制性公積金計劃(一般)規例》(簡稱《規例》)中亦稱「轉移信託人」)-指轉出閣下的權益的計劃的信託人。

- (3) If you wish to transfer your benefits from one scheme to another, please be aware of how the transferred-in benefits will be invested. In general, the transferred-in benefits will be invested according to the default investment strategy ("DIS") if you either (a) do not give or have not given any investment instructions for the account to your new trustee or (b) have given investment instructions for the account to invest benefits according to the DIS. Please approach your new trustee to seek clarification, where necessary. If you wish to change or specify an investment instruction for the account in the new scheme, please also approach the new trustee. 如欲把權益從一個計劃轉移至另一個計劃，請留意轉入帳戶的權益將會如何投資。一般而言，如閣下(a)沒有或尚未就有關帳戶向閣下的新信託人給予任何投資指示；或(b)已就有關帳戶給予投資指示，要求把權益按照預設投資策略投資，則轉入該帳戶的權益將按照預設投資策略投資。如有需要，請向新信託人查詢詳情。如欲就新計劃的帳戶更改或給予投資指示，亦請聯絡新信託人。
- (4) If you have reached, or are approaching, the age of 50 and your benefits are currently invested according to the DIS of the scheme, you should be aware that the de-risking mechanism of the DIS starts at the age of 50. If the annual de-risking of your investment in the DIS and your transfer request take place at around the same time, the trustee of the scheme shall sequence the de-risking and the transfer request in accordance with its procedures and in compliance with the Mandatory Provident Fund Schemes Ordinance. Please consult the relevant trustee(s) if you wish to know the details of how the trustee(s) will handle these transactions. 如閣下已年滿或快將年滿50歲，而現時閣下的權益是按照計劃的預設投資策略投資，請留意預設投資策略的降低投資風險機制，會由計劃成員年滿50歲開始運作。如計劃的信託人在預設投資策略下按年降低閣下的投資風險的時間，與接獲閣下的轉移權益申請的時間相當接近，該計劃的信託人將根據其運作程序及在符合《強制性公積金計劃條例》規定的情況下，訂定處理降低風險及轉移權益的次序。如欲瞭解信託人如何處理該等交易，請向相關信託人查詢詳情。
- (5) Please ensure that you have a personal account or a contribution account in the new scheme. Otherwise, you have to enroll in that scheme before you submit Form MPF(S)-P(M) to the new trustee. 請確保閣下在新計劃已開立個人帳戶或供款帳戶。否則，閣下須先行登記參加該計劃，然後才向新信託人提交第 MPF(S)-P(M) 號表格。
- (6) If you wish to transfer-out the benefits from more than one accounts, you should submit a separate Form MPF(S)-P(M) for each of those accounts. 如欲從多於一個帳戶轉出權益，請就每個帳戶分別提交一份第 MPF(S)-P(M) 號表格。

- (7) If you wish to transfer-out the benefits from your contribution account during employment, you should complete Form MPF(S)-P(P). 如欲在現職期間從閣下的供款帳戶轉出權益，請填寫第 MPF(S)-P(P) 號表格。
- (8) For each account, a scheme member should transfer the entirety of his benefits therein in a lump sum except the part of the benefits derived from voluntary contributions which the scheme member may elect to withdraw in accordance with the governing rules of the original scheme. 就每一個帳戶，除了由自願性供款所產生的權益或可根據原計劃管限規則選擇提取外，計劃成員應把帳戶內的所有權益整筆轉移。
- (9) In order to prevent a third party from filling in incorrect information, please **DO NOT sign on a blank form**. After the completed Form MPF(S)-P(M) has been received by the new trustee, the administration procedures taken by the trustees may not be reversible. 為免被第三者填上不正確的資料，**請勿在空白的表格上簽署**。在新信託人收到已填妥的第 MPF(S)-P(M) 號表格後，之前由信託人採取的行政步驟未必能夠撤銷。
- (10) If any information provided on Form MPF(S)-P(M) (including the signature) is incorrect or incomplete, the trustees may not be able to process your benefit transfer request. 若閣下在第 MPF(S)-P(M) 號表格上所提供的任何資料（包括簽署）不正確或不完整，信託人可能無法處理閣下的權益轉移要求。
- (11) Please refer to the publication of the Mandatory Provident Fund Schemes Authority ("MPFA") available from the MPFA website (www.mpfa.org.hk) for the factors to consider when choosing a scheme and the potential risks involved in MPF investment. 有關選擇計劃時各項考慮因素及強積金投資的潛在風險，請參閱強制性公積金計劃管理局（「積金局」）網站（www.mpfa.org.hk）的相關宣傳刊物。
- (12) Information about the new scheme is set out in the offering document of that scheme. This information will assist you in making a decision about whether to make a transfer of benefits to that scheme. Please contact the relevant trustee for enquiries about account details and information on specific schemes or funds. 新計劃的要約文件載有該計劃的資料，這些資料將有助閣下決定是否把權益轉移至該計劃。如欲查詢帳戶詳情及個別計劃或基金的資料，請聯絡相關信託人。
