

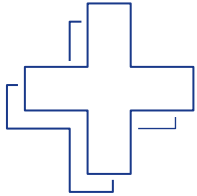


Invesco S&P 500® High Dividend Low Volatility ETF (SPHD)

Invesco S&P 500® High Dividend Low Volatility ETF (SPHD) is constructed to deliver enhanced income with less volatility than traditional equity-based strategies.

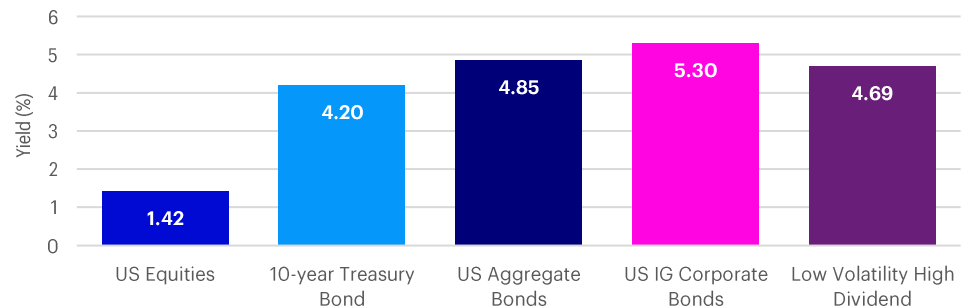
Seeking higher income, lower volatility



Screening for both yield and volatility, the index methodology may help reduce the volatility associated with dividend strategies.

A dividend strategy that seeks to avoid names that have fallen into a value trap scenario by selecting securities that have demonstrated the lowest volatility over the trailing 12 months.¹

¹ SPHD's underlying index selects the 50 least volatile stocks (measured by trailing 252-day standard deviation) from the 75 highest yielding stocks of the S&P 500.

SPHD declined less than the S&P 500 in over half of all large market declines since inception

² Weighted Harmonic Average Stock Price-to-Earnings Ratio (**P/E Ratio**) is the share price divided by the earnings per share. It is measured on a 12-month trailing basis. Weighted Harmonic Average Stock Price-to-Book Value Ratio (**P/B Ratio**) is the ratio of a stock's market price to a company's net asset value. Weighted Harmonic Average is a method of calculating an average value that lessens the impact of large outliers and increases the impact of small ones.

Weighted Average Return on Equity is net income divided by net worth. **Weighted Market Capitalization** is the sum of each underlying securities' market value.

S&P 500 Low Volatility High Dividend Index consists of 50 securities traded on the S&P 500 Index that historically have provided high dividend yields and low volatility.

US Generic Government 10 Year Index tracks the yield of the 10 Year US Treasury

Bloomberg US Aggregate Bond Index is a managed index considered representative of the US investment-grade, fixed-rate bond market.

Bloomberg US Corporate Bond Index measures the investment grade, fixed-rate, taxable corporate bond market.

Standard deviation is a measure of the dispersion of a set of data from its mean. It is applied to the annual rate of return of an investment to measure the investment's volatility.
