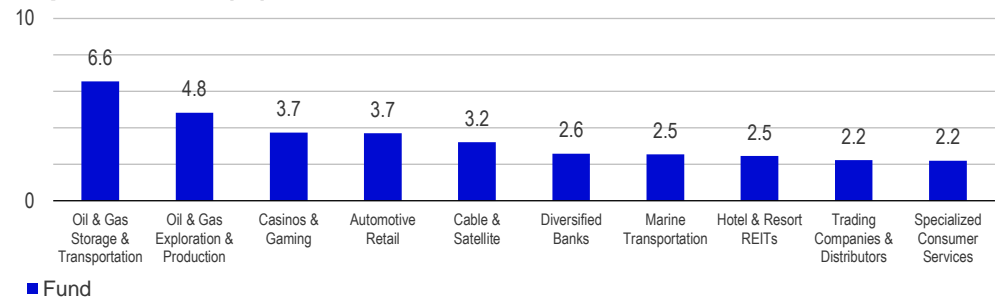
What this fund does

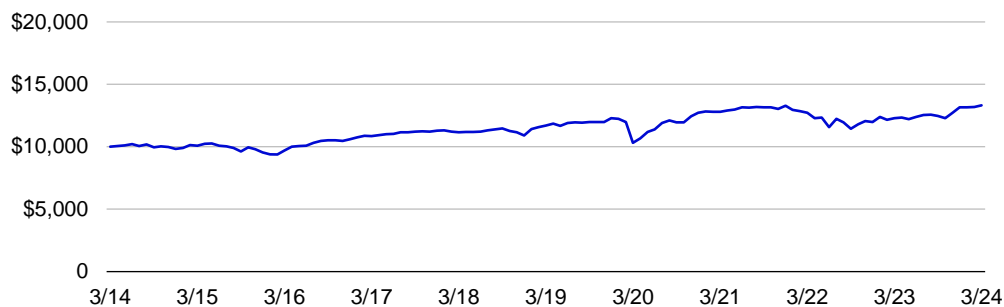
