## **DISTRIBUTION NOTICE**

Form 1099-DIV for the calendar year will report distributions for federal income tax purposes. The amounts and sources of the following distribution are estimates and as noted above are not being provided for tax reporting purposes. During the month of September 2015, the Fund declared a monthly distribution, which is payable to shareholders on September 30, 2015. This distribution, determined in accordance with generally accepted accounting principles, is estimated to be from the following sources: (1) \$0.0243 per share from net investment income; and (2) \$0.0017 per share from return of principal.
