Market overview

Global equity markets had a positive fourth quarter, rallying strongly during the last two months. The guarter started with all three US major indices declining as investment sentiment appeared weighed down by the uncertainty around the future direction of interest rates and the conflict in Middle East, as well as by mixed labor market data. European equities also posted negative returns due to slowing growth and apparently low consumer confidence, while both the European Central Bank and the Central Bank of England kept interest rates on hold. US equities regained traction in November with all three major indices registering positive returns as the "Magnificent Seven" (Alphabet, Amazon, Apple, Meta, Microsoft, NVIDIA, and Tesla) steered gains. Investor sentiment appeared boosted by a growing sense that interest rates in developed markets may have peaked. US equities continued rallying in December, with the Dow Jones and S&P 500 nearing record highs following the US Federal Reserve's (Fed) dovish pivot. With US Treasury yields falling and strong labor market data, investors appeared to end the year growing more confident of a possible "soft landing" where the U.S. economy avoids a recession as the Fed kept interest rates on hold at a 22-year high. European equities markets followed along, as inflation continued dropping and interest rates remained unchanged.

Performance highlights

- The portfolio is passively managed relative to its benchmark and its Class RZ units at net asset value (NAV) underperformed the MSCI World SRI Index in the fourth quarter. (Please see the investment results table on page 2 for portfolio and index performance.)
- On a relative basis, the MSCI World SRI Index outperformed its parent benchmark, the broader MSCI World Index, due to strength in the information technology sector. Here, an overweight to Microsoft aided returns as the stock increased more than 19% over the course of the period.
- From a sector perspective, information technology, financials, and industrials were the largest positive contributors to the portfolio's absolute return. There were no detractors for the
- The portfolio's large allocation to the US, representing more than two-thirds of the index, added to returns as US companies performed well for the quarter. The Netherlands, France, Japan, and Canada also aided the portfolio's performance, though to a smaller extent.

Contributors to performance

- The largest individual contributor to the portfolio's absolute performance by far was Microsoft (+19.34% return for the guarter), due to the size of its position (more than 16% of the
- **ASML** (+27.54%), **Home Depot** (+15.46%) and **Adobe** (+17.00%) also made positive contributions.

Detractors from performance

- In the fourth quarter, **Tesla** (-0.70%) had the largest subtraction from absolute return because of its large weight in the portfolio. Valero (-7.50%) and Becton, Dickinson, and Company (-5.30%) also hurt performance.

Positioning and outlook

- The portfolio is passively managed seeking to closely track the MSCI World SRI Index.
- Country, sector and security weights will closely mirror those of the index.
- As of guarter end, the largest sector weights were in IT, financials and consumer discretionary. The largest country weights were in the US, Japan and Canada.
- The MSCI World SRI Index targets about 25% of the parent index (MSCI World Index) market capitalization in companies with high ESG ratings compared to their sector peers and applies a list of values-based exclusion criteria such as controversial weapons, tobacco, alcohol, gambling, etc. The index also excludes companies involved in material ESG controversies.

Because the underlying fund operates as a passively managed index fund, adverse performance of a particular stock ordinarily will not result in its elimination from the underlying fund's portfolio. Ordinarily, the Adviser will not sell the underlying fund's portfolio securities except to reflect changes in the stocks that comprise the Index, or as may be necessary to raise cash to pay underlying fund shareholders who sell underlying fund shares.

The underlying fund's use of a representative sampling approach will result in its holding a smaller number of securities than are in the index and in holding securities not included in the index. As a result, underperformance of securities held by the fund could result in a greater decline in NAV than would be the case if all of the securities in the index were held, and the underlying fund may not track the return of the index as well as it would have if it held all of the securities in the index.
