Form 8937, Lines 15 and 16: A shareholder will recognize gain or loss equal to the difference between the amount received in the redemption (see above) and the shareholder's tax basis in the redeemed ARPS, provided that the redemption is treated as a distribution in part or full payment in exchange for the ARPS redeemed. A redemption of ARPS generally will be treated as a taxable sale or exchange of such shares for federal income tax purposes, provided (a) the redemption is not essentially equivalent to a dividend, (b) the redemption is a substantially disproportionate redemption, or (c) the redemption is a complete redemption of a shareholder's entire interest in the Fund. Constructive stock ownership rules apply for purposes of determining whether a redemption is treated as a sale or exchange for federal income tax purposes.
