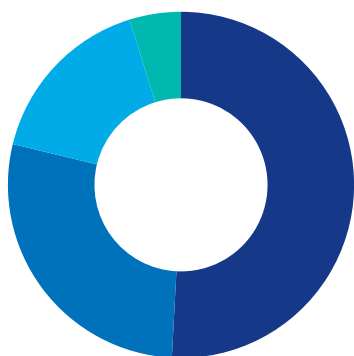

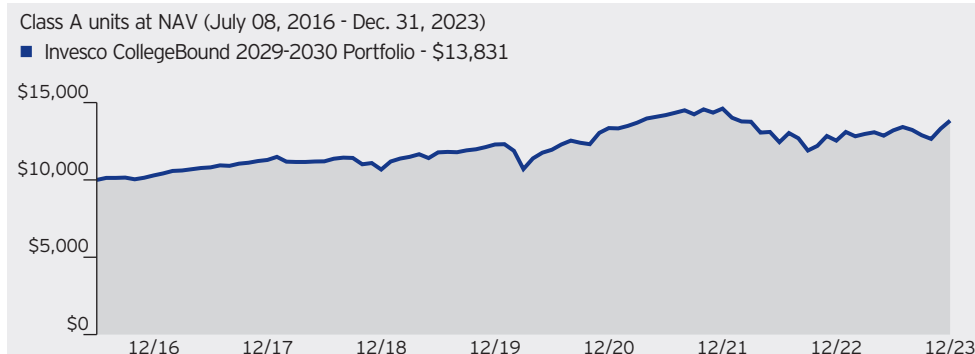

About risk

Any effects of LIBOR transition and the adoption of alternative rates could result in losses to the Portfolio.
