DISTRIBUTION NOTICE

Form 1099-DIV for the calendar year will report distributions for federal income tax purposes. This distribution, determined in accordance with generally accepted accounting principles, is estimated to be from the following sources: (1) \$0.0710 per share from net investment income; (2) \$0.5071 per share gain from sale of securities.
