



Notice of the Sources of Fund Distribution

Form 1099-DIV for the calendar year will report distributions for US federal income tax purposes. The Fund's annual report to shareholders will include information regarding the tax character of Fund distributions for the fiscal year. This Notice is sent to comply with certain US Securities and Exchange Commission requirements. The amounts and sources of the following distribution are estimates and as noted above are not being provided for tax reporting purposes. The final determination of the source and tax characteristics of all distributions in 2022 will be made after the end of the year.

Invesco Select Risk Moderate Investor Fund

During the month of December 2022, the Fund declared a distribution, which is payable to shareholders on December 21, 2022. This distribution, determined in accordance with generally accepted accounting principles, is estimated to be from the following sources: (1) \$0.1925(Class R6), \$0.1925(Class R5), \$0.1839(Class Y), \$0.1580(Class A), \$0.1304(Class R), \$0.0757(Class C), \$0.1677(Class S) per share from net investment income; and (2) \$0.2607 per share gain from sale of securities. After giving effect to this distribution, net unrealized depreciation of portfolio securities is \$0.4974 per share.
