14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ On May 15, 2020, Invesco Pennsylvania Tax Free Income Fund, EIN: 36-3495811, merged into Invesco Oppenheimer Rochester Pennsylvania Municipal Fund, EIN: 13-3532998. The Fund paid a monthly distribution to shareholders from January 2020 to April 2020. A portion of each distribution constitutes a non-taxable return of capital. See Attachment 2.
