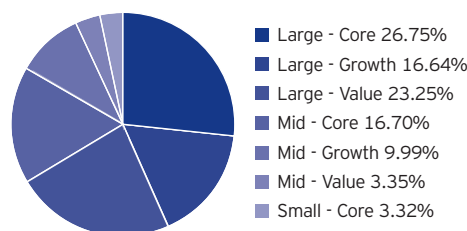

Style breakdown

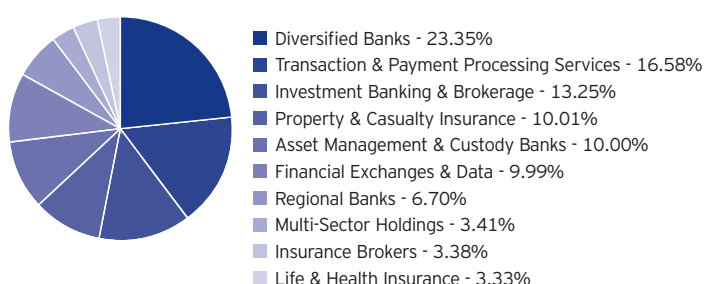
