

Invesco S&P 500 Value with Momentum ETF

Fund description

The Invesco S&P 500 Value With Momentum ETF (Fund) is based on the S&P 500® High Momentum Value Index (Index). The Fund will invest at least 90% of its total assets in securities that comprise the Index. The Index tracks the performance of stocks in the S&P 500® Index that have the highest value and momentum score. Constituents are selected through a two-step process: first, the 200 stocks from the S&P 500 Index with the highest value scores are identified; second, from among those 200 stocks, 100 securities stocks with the highest positive momentum scores are identified. The index is constituted of these 100 stocks, weighted by their value score. The Fund and the Index are rebalanced and reconstituted semi-annually.

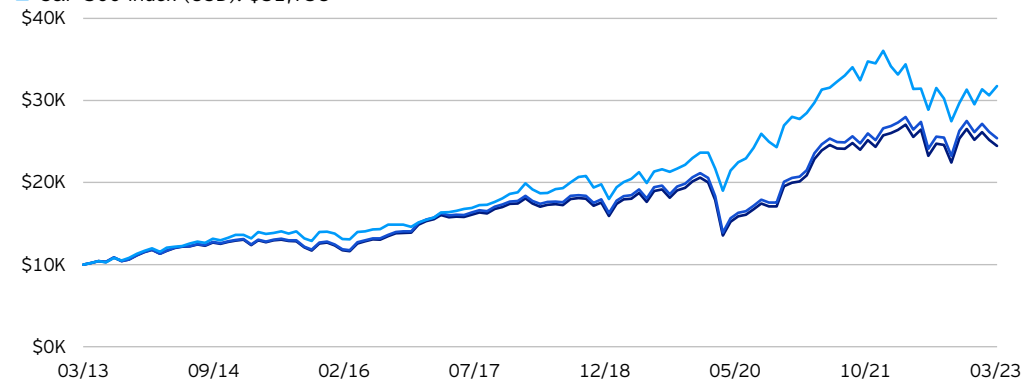

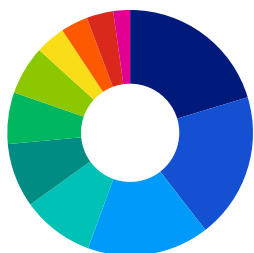

Glossary

30 Day SEC Unsubsidized Yield reflects the 30-day yield if the investment adviser were not waiving all or part of its fee or reimbursing the fund for part of its expenses. Total return would have also been lower in the absence of these temporary reimbursements or waivers.

30 Day SEC Yield is based on a 30-day period and is computed by dividing the net investment income per share earned during the period by the maximum offering price per share on the last day of the period.

Intraday NAV is a symbol representing estimated fair value based on the most recent intraday price of underlying assets.

Weighted Harmonic Average Stock Price-to-Book-Value Ratio (P/B Ratio) is the ratio of a stock's market price to a company's net asset value.

Weighted Harmonic Average Stock Price-to-Earnings Ratio (P/E Ratio) is the share price divided by earnings per share. It is measured on a 12-month trailing basis.

Weighted Average Return on Equity is net income divided by net worth.

Weighted Market Capitalization is the sum of each underlying securities market value.
