

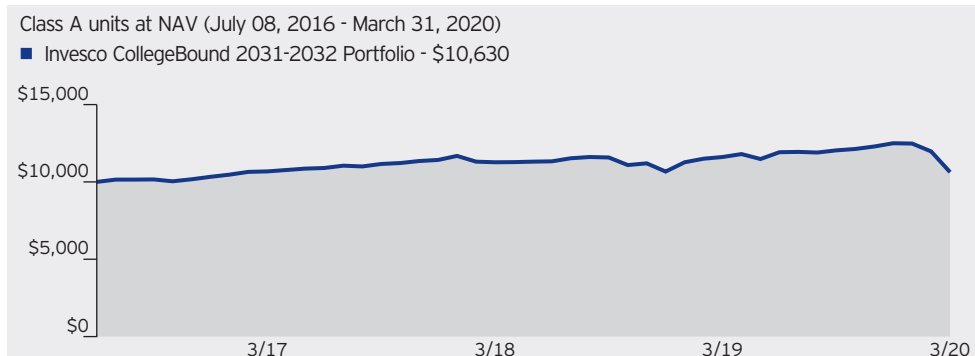


Invesco CollegeBound 2031-2032 Portfolio

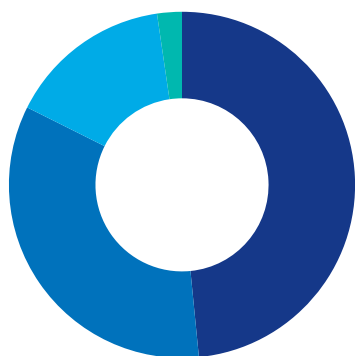
