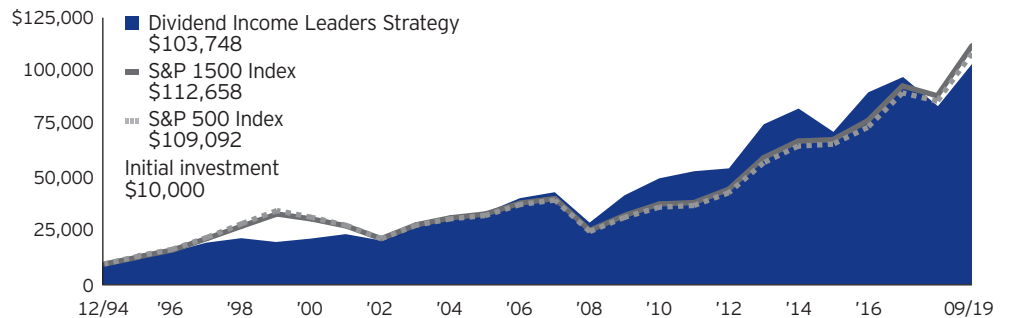

Objective

The Portfolio seeks to provide current income and the potential for capital appreciation by using an enhanced index strategy* to select an equally weighted portfolio of 33 dividend paying stocks derived from each sector of the S&P 1500[®] Index. The selection process seeks to identify the top dividend yielding stocks across the primary market sectors.

The graph represents a hypothetical \$10,000 investment in the trust strategy (not any actual trust) and the S&P 1500 Index and the S&P 500 Index from 12/31/94 through 09/30/19. The graph assumes the sum of the initial investment (\$10,000) and all dividends (including those on stocks trading ex-dividend as of the last day of the year) and appreciation during a year are reinvested at the end of that year.

All strategy performance is hypothetical (not any actual trust) and reflects trust sales charges at the beginning of each calendar year of 1.85% and expenses but not brokerage commissions on stocks or taxes. Past performance is no guarantee of future results and the payment of stock dividends is not assured and may vary over time. Actual returns will vary from hypothetical strategy returns due to timing differences and because the trust may not be invested equally in all stocks or be fully invested at all times. Returns are calculated by taking year-end prices, subtracting them from the prices at the end of the following year (adjusting for any stock splits that might have occurred during the year) and adding dividends received for the period divided by starting price. Average annual total return and total return measure change in the value of an investment assuming reinvestment of all dividends and capital gains. Average annual total return reflects annualized change while total return reflects aggregate change and is not annualized.

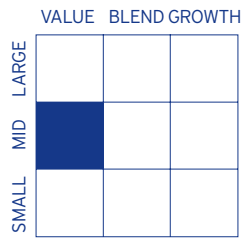

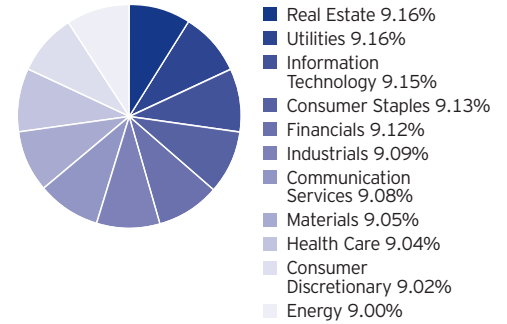
Equity style analysis



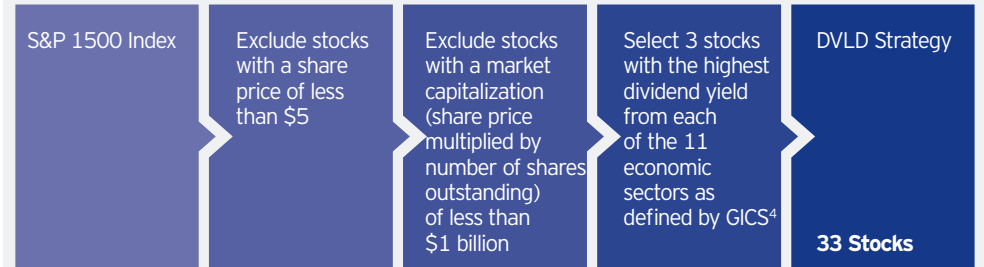
