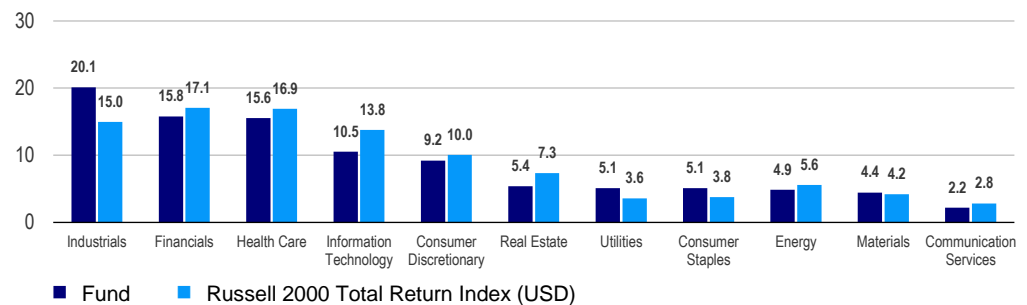

The fund seeks to provide capital appreciation through a high conviction approach focused on identifying small-cap companies with what we believe poses superior execution and quality management teams.

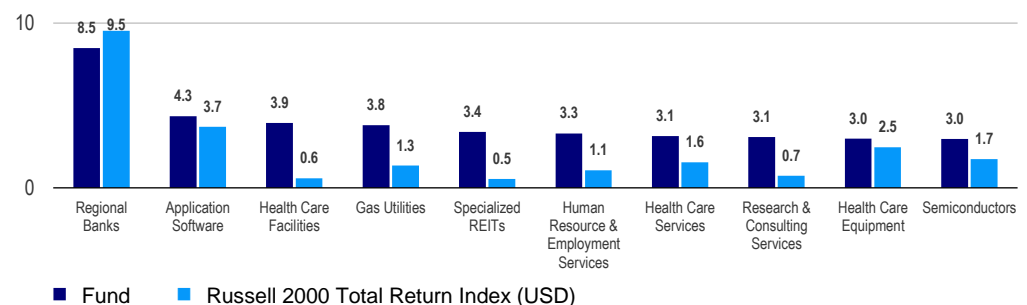

Sector breakdown (% of total net assets)



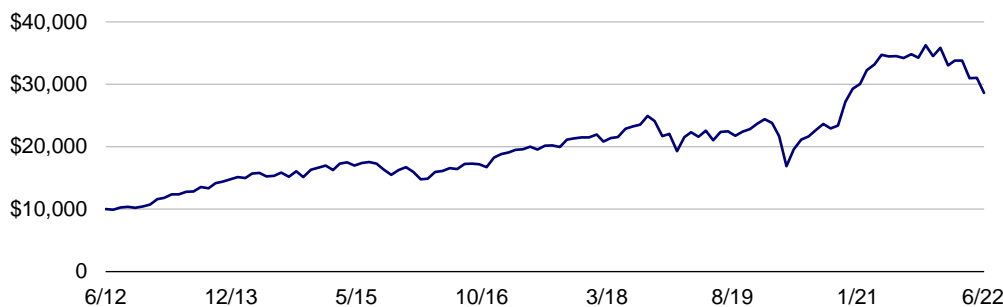
Top industries (% of total net assets)

The fund was rated among 129, 123, 121 and 105 funds within the Foreign Small/Mid Growth Category for the overall period, three, five and 10 years, respectively.

The fund holdings are organized according to the Global Industry Classification Standard, which was developed by and is the exclusive property and service mark of MSCI Inc. and Standard & Poor's.

The **three-year EPS growth rate** is a weighted average of each stock's growth rate in earnings per share (EPS). EPS is total earnings divided by the number of shares outstanding. The five-year dividend growth rate is the weighted average of each stock's annualized percentage rate of growth in dividend yield over five years. The three-year EPS and five-year dividend growth rates are not forecasts of fund performance. **Alpha** (cash adjusted) is a measure of performance on a risk-adjusted basis. **Beta** (cash adjusted) is a measure of relative risk and the slope of regression. The **median 12-Month Fwd Growth Rate** is the percent change between the next twelve months' mean EPS estimate and the previous twelve months' actuals. The **price/book ratio** is the market price of a stock divided by the book value per share. **R-squared** is the percentage of a fund or security's movements that can be explained by movements in a benchmark index. **Return on equity (ROE)** is net income divided by net worth. **Sharpe Ratio** is a risk-adjusted measure calculated using standard deviation and excess return to determine reward per unit of risk. A higher Sharpe ratio indicates better risk-adjusted performance. **Standard deviation** measures a fund's range of total returns and identifies the spread of a fund's short-term fluctuations. **Tracking Error** is defined as the expected standard deviation of a portfolio's excess return over the benchmark index return. The **up and down capture** measures how well a manager was able to replicate or improve on periods of positive benchmark returns and how severely the manager was affected by periods of negative benchmark returns.
