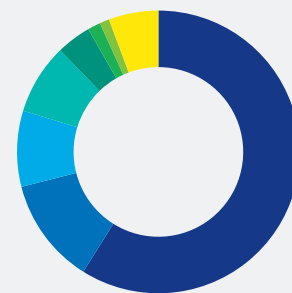

Risks of the Underlying Holding
