DISTRIBUTION NOTICE

Form 1099-DIV for the calendar year will report distributions for U.S. federal income tax purposes. The amounts and sources of the following distribution are estimates and as noted above are not being provided for tax reporting purposes. During the month of January 2017, the Fund declared a monthly distribution, which is payable to shareholders on January 31, 2017. This distribution, determined in accordance with generally accepted accounting principles, is estimated to be from the following sources: (1) \$0.0838 per share from net investment income; and (2) \$0.0092 per share from return of principal.
