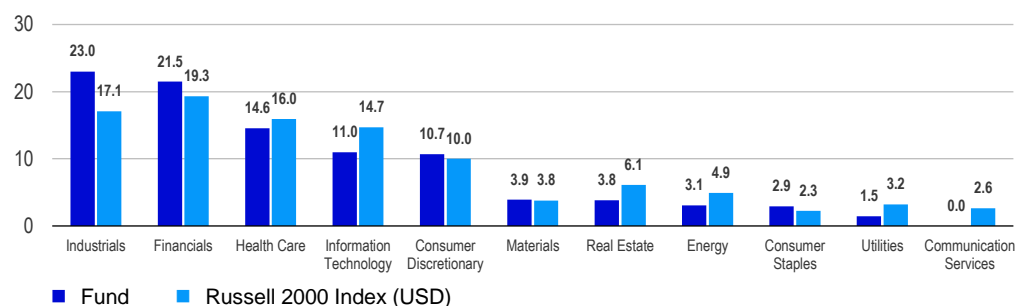
What this fund does

The fund offers investors exposure to high-quality US small-cap equities and seeks to outperform the benchmark with less volatility over a full market cycle.

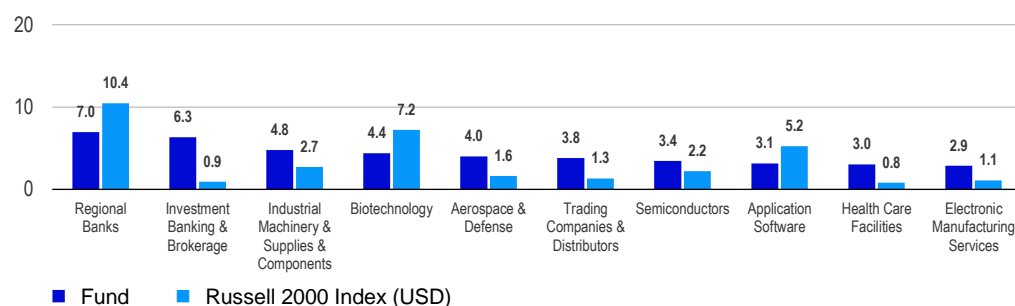

Sector breakdown (% of total net assets)



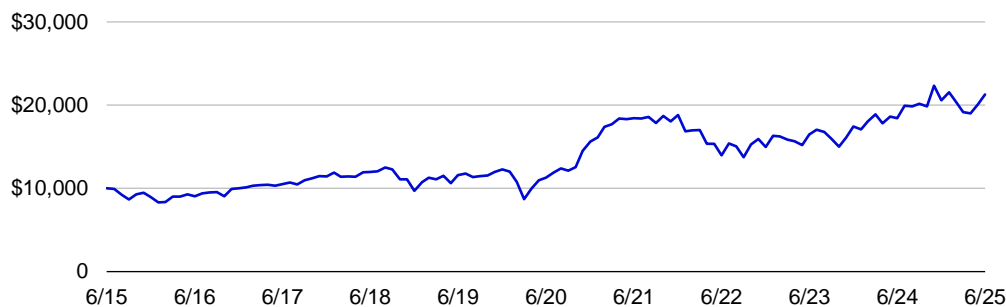
Top industries (% of total net assets)
