Had fees not been waived and/or expenses reimbursed, the SEC yields would have been 1.46% for Class A shares, 0.76% for Class C shares and 1.75% for Class Y shares. The 30-day taxable-equivalent SEC yields would have been 2.50% for Class A shares, 1.30% for Class C shares and 2.99% for Class Y shares.

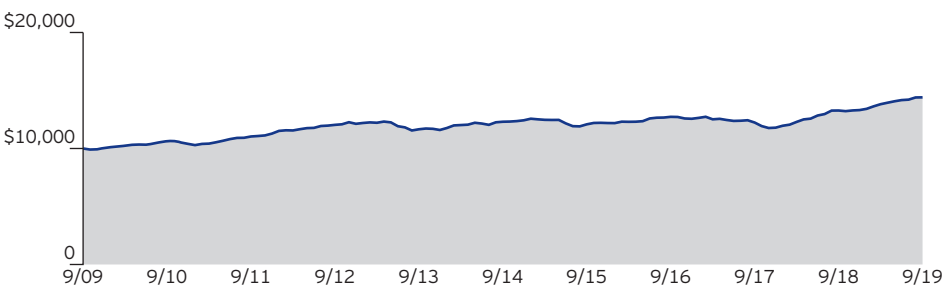
