Manager perspective and outlook

- Despite the rapid interest rate hikes of 2022 and 2023, the US economy continued to grow, benefiting from continued consumer strength.
- Municipal bonds ranked as one of the best performing asset classes for 2023, with November and December accounting for the majority of the annual total return.
- The US Federal Reserve (Fed) held the federal funds rate steady at 5.50% in November and December. The Fed acknowledged that growth has slowed and inflation has eased as it pivoted to a transitional stance regarding future rate hikes.¹ The announcement sparked a decline in rates, with municipals outperforming Treasuries during the rally.
- Despite the performance rebound, municipal fund outflows were \$11 billion in the fourth quarter and \$17 billion for 2023.²
- Fourth quarter new issuance was \$99 billion, 39% higher than the fourth quarter of 2022.³ Total new issuance for 2023 was \$369 billion, in line with last year.
- Municipal issuers have taken advantage of federal pandemic aid and healthy tax receipts to build solid credit foundations. In 2023, Moody's Investors Service and S&P Global Ratings upgraded more than 1,400 ratings and downgraded less than 350 — an upgrade/downgrade ratio of 4 to 1.⁴
- With Fed rate hikes likely behind us, we believe high absolute yields, low issuance, strong fundamentals, and investor migration out of cash will present positive opportunities for municipal bonds.

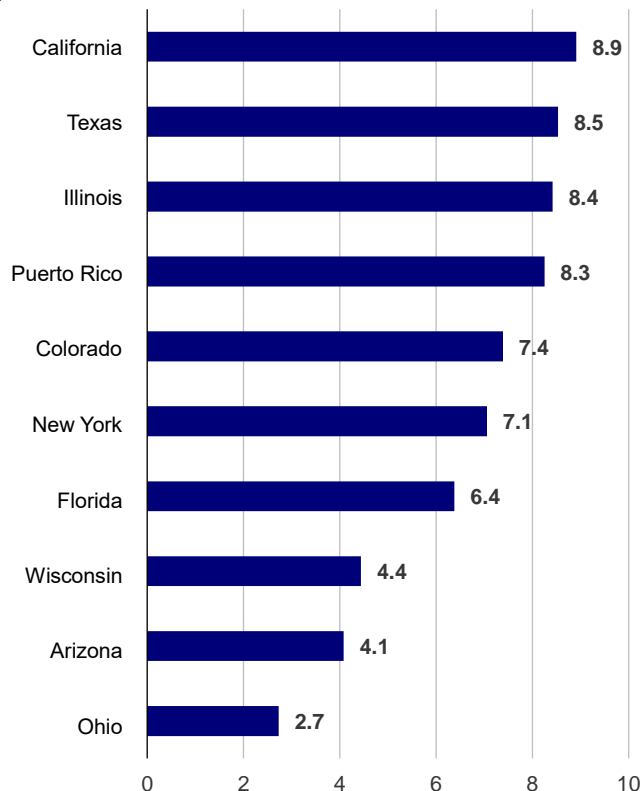
Portfolio positioning

Yield Curve and Duration Positioning: Overall, we maintain a constructive outlook for duration and are looking to selectively add longer duration securities to the fund when appropriate and according to prospectus guidelines. We maintain an overweight in the shorter maturity segment of the yield curve given the fund's short duration mandate.

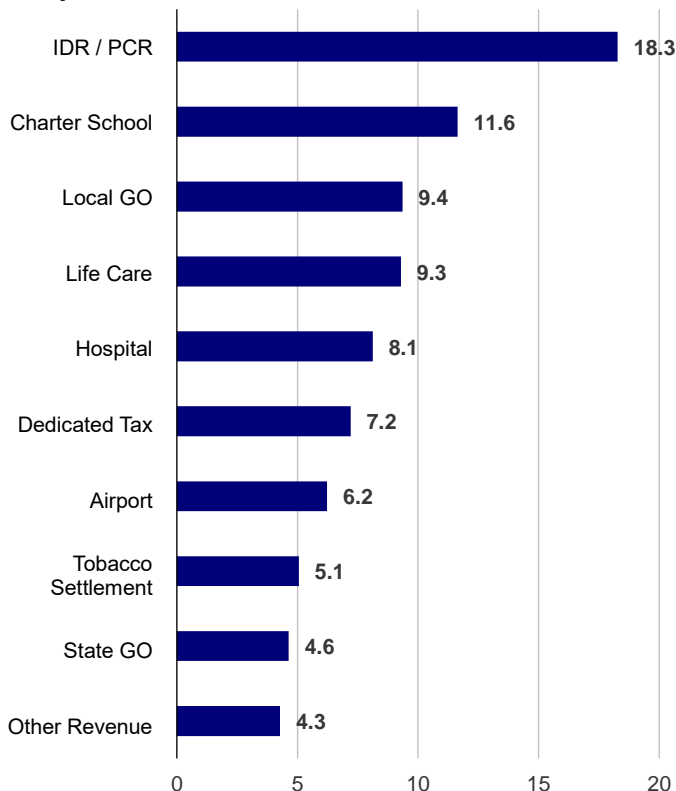
Sector Allocations: We maintain an overweight position in revenue bonds relative to state and local general obligation bonds. Within the revenue bond segment, the fund's largest exposures are in the industrial development revenue/pollution control revenue (IDR/PCR), charter school and continuing care retirement community sectors.

Credit Conditions: We maintain a positive view on fundamentals in the municipal market as upgrades of credit ratings continue to outpace downgrades. The health care sector has been affected most by higher inflation and labor costs. However, we have relied on our extensive bottom-up research capabilities to find pockets of opportunity in the sector.

Performance highlights

The fourth quarter was marked by a rally in the municipal market in November and December. This caused yields in the 2-year and 5-year segments of the municipal yield curve to fall by 1.14% and 1.13%, respectively. As a result, all sectors of the municipal market had positive returns. The fund's overweight in the industry development revenue/pollution control revenue sector contributed the most to relative return. The fund's shorter duration and emphasis on the shorter maturity segment of the yield curve was disadvantageous as rates fell during the quarter.

Contributors to performance

Contributors to relative return this quarter included the following:

The fund's overweight exposures in the airport and higher education sectors added to relative return for the quarter. The fund's overweight exposure in credits rated A and BBB added to relative performance during the quarter.

Detractors from performance

Detractors from relative return this quarter included the following:

The fund's underweights in the dedicated tax and multi-family housing sectors detracted from relative performance. The fund's underweight exposure in bonds with effective durations longer than 10 years detracted from performance relative to the index during the quarter.

Total return would have also been lower in the absence of these temporary reimbursements or waivers. **Option adjusted duration** is a measure, as estimated by the fund's portfolio managers, of a bond fund's price sensitivity to changes in interest rates. It takes into account mortgage prepayments, puts, adjustable coupons and potential call dates. **Tax equivalent 30-day SEC yield** quoted above is based on the 2023 top federal tax rate of 40.8%, including the 3.8% tax on earned income under the Patient Protection and Affordable Care Act, as applicable.
