Asset Backed Commercial Paper, Financial Company Commercial Paper, Other Commercial Paper and Other Notes are generally traded on a discount basis; the coupon rate shown is the discount rate received by the Fund at the time of purchase. For a variable or increasing rate security, the coupon rate represents the current interest rate. Other securities normally bear interest at the coupon rates shown.
