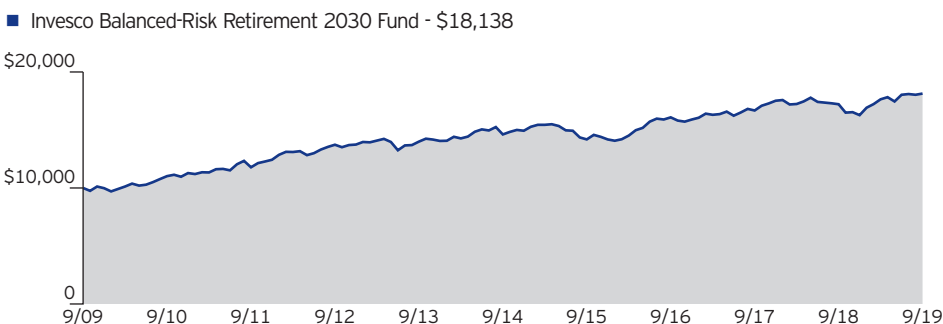

From Nov. 4, 2009, through Nov. 30, 2009, the index was composed of MSCI World Index and JP Morgan Global Government Bond Index. Since Dec. 1, 2009, the index is composed of MSCI World Index and Bloomberg Barclays U.S. Aggregate Index. The composition of the index may change from time to time based upon the target allocation of the fund and will likely be altered in the future to better reflect the fund's objective. About risk

Invesco Balanced-Risk Allocation Fund (IBRA), an underlying fund, will invest in commodities through a wholly-owned subsidiary of that underlying fund organized under the laws of the Cayman Islands (the Subsidiary).
