Market overview

- + US bonds posted strong nominal results for the quarter as rates fell precipitously amid a decelerating global economy and persistent trade disputes between the US and China. Global risks remained a headwind to growth, especially in Europe given uncertainties of Brexit, auto tariffs and Italy's ongoing crisis. The Federal Reserve cut the federal funds rate by 0.25% twice during the quarter, lowering the overnight yield's target range to 1.75% - 2.00%. Bond markets responded well to these policy actions and, at quarter end, US markets were still pricing in additional Fed rate cuts.
- + The yield curve, as measured by the yield differential between 2-year and 30-year Treasuries, flattened notably, driven by investor concerns about global growth and modest inflation risks.
- + Structured credit sectors - commercial mortgage-backed (CMBS), asset-backed (ABS) and residential mortgage backed (RMBS) securities - posted positive returns amid the fervor for yield, as these sectors are less affected by declining global growth due to their underlying US collateral. The Agency mortgage-backed securities (MBS) sector marginally outperformed comparable maturity Treasuries, even as falling interest rates escalated prepayment risks.
- + Yield spreads between US investment grade credit and comparable duration US Treasuries narrowed during the quarter, slightly rewarding credit investors. High-yield credit also delivered a positive return largely due to the tailwind provided by lower government rates as credit spreads between high-yield and Treasuries widened slightly during the quarter.
- + The emerging market debt sector had a positive return for the quarter despite a challenging environment for credit markets within the asset class.

Positioning and outlook

- + We do not foresee a significant slowdown in US growth, but downside risks loom. US manufacturing data has slowed, and consumption data likely peaked in the second quarter. Though this backdrop is positive for US Treasuries, valuations appear to be high and currently reflect expectations for one more Fed rate cut in 2019.
- + The fund is heavily focused in US structured securities - CMBS, ABS and RMBS - which, in our view, still offer enhanced yield, supportive fundamentals and favorable supply/demand dynamics.
- + Within CMBS, we believe senior non-Agency CMBS offers attractive income and potential for incremental narrowing of the yield advantage over Treasuries in the near term. We currently prefer seasoned subordinate credits that benefit from embedded property price appreciation and declining sensitivity to changes in credit spreads.
- + Within RMBS, we favor high quality non-qualified mortgages to take advantage of a widening of the yield advantage over Treasuries that is related to elevated supply of RMBS.
- + Regarding ABS, we see value in high quality sectors within the benchmark, as well as certain sectors not represented in the benchmark that continue to benefit from the inversion at the short end of the yield curve (shorter maturity securities yielding more than securities that are longer) and attractive yield.
- + The fund has allocations to emerging market debt and high-yield corporates, consisting of issues where we have high conviction in favorable performance. The fund also has an allocation to mortgage REITs.

Performance highlights

- + Invesco Income Fund Class A shares at net asset value (NAV) underperformed its broad-based benchmark for the quarter. (Please see the investment results table on page 2 for fund and index performance.)

Contributors to performance

- + The fund's security selection within the CMBS sector boosted relative return.
- + The fund's allocation to high-yield credit, which is not represented in the index, also added to relative return for the quarter.

Detractors from performance

- + The fund's duration and yield curve positioning detracted from relative return for the quarter.
- + The fund's underweight in MBS also dragged on relative performance.
