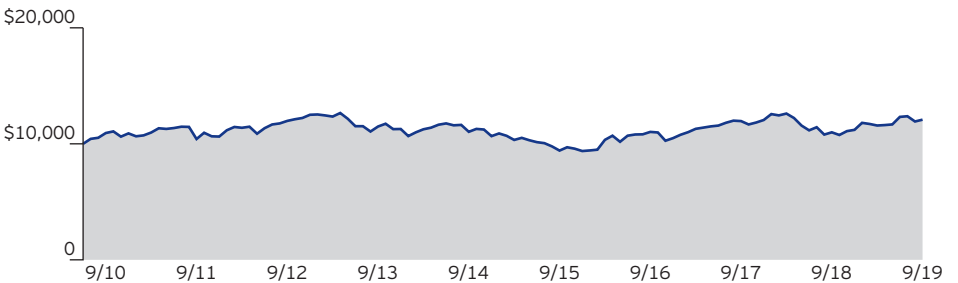

It takes into account mortgage prepayments, puts, adjustable coupons and potential call dates.

Ratings are based on a risk-adjusted return measure that accounts for variation in a fund's monthly performance, placing more emphasis on downward variations and rewarding consistent performance. Open-end mutual funds and exchange-traded funds are considered a single population for comparison purposes. Ratings are calculated for funds with at least a three year history. The overall rating is derived from a weighted average of three-, five- and 10-year rating metrics, as applicable, excluding sales charges and including fees and expenses. Had fees not been waived and/or expenses reimbursed currently or in the past, the Morningstar rating would have been lower. Class A shares received 5 stars for the overall, 4 stars for the three years and 5 stars for the five years. The fund was rated among 68, 68 and 60 funds within the Morningstar Emerging-Markets Local-Currency Bond Category for the overall period, three and five years, respectively.
