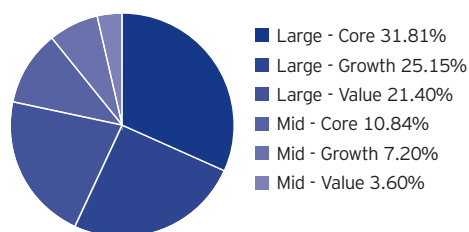

### Style breakdown

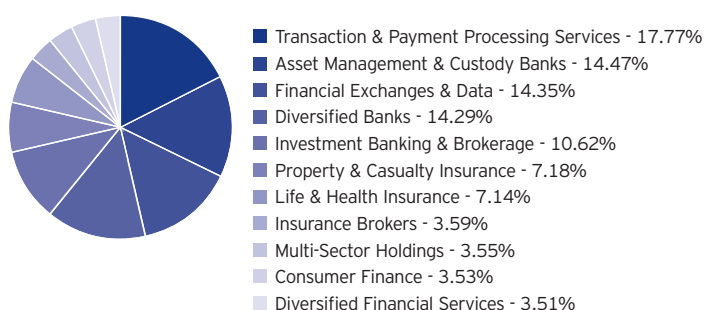
