#### Objective

The Portfolio seeks to provide current income and the potential for capital appreciation. The Portfolio seeks to achieve its objective by investing in a portfolio of dividend-paying shares of common stocks and exchange-traded funds ("ETFs"). The common stocks are chosen from the S&P 500 Dividend Aristocrats Index, an index consisting of stocks of those companies in the S&P 500 Index that have increased their actual dividend payments in each of the last 25 years. The ETFs are strategically chosen based on their exposure to US and foreign fixed income securities of varying maturities, subcategories and credit quality. Invesco Capital Markets, Inc. is the Sponsor of the Portfolio.






## Equity Style breakdown

#### About risk

There is no assurance the trust will achieve its investment objective. An investment in this unit investment trust is subject to market risk, which is the possibility that the market values of securities owned by the trust will decline and that the value of trust units may therefore be less than what you paid for them.
