## What this strategy does

The strategy invests entirely in investment grade tax-exempt municipal bonds and targets a weighted average portfolio duration of 3.75 years with individual bond maturities no greater than 12 years. This limited-duration strategy exhibits moderate sensitivity to changes in interest rates.

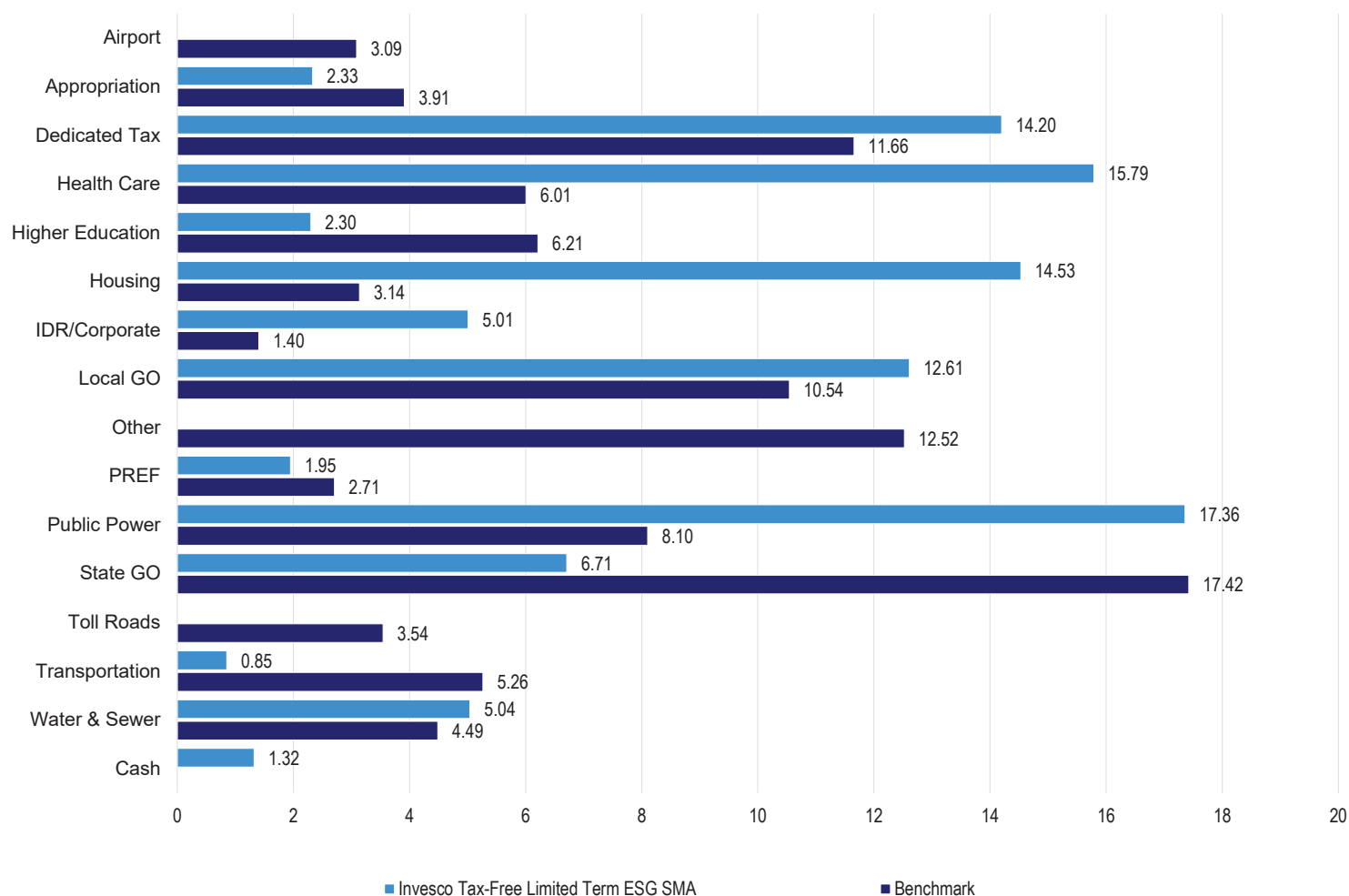

All portfolios are actively managed with tax efficient considerations in regard to state and local income taxes. All holdings within the portfolios are investment grade. Eligible securities include those in the municipal, U.S. Treasury, government-related, and corporate sectors of the investment-grade bond market. The weighted average duration of the portfolios included in the composite is between 3.5 – 4.5 years, and the weighted average credit rating of member portfolios is single A or above. The composite name was changed in September 2015. Previously, the composite name was SNW HIP Municipal Composite – Intermediate. The name of the Composite was changed from Municipal Impact Intermediate to Impact Municipal Intermediate on June 30, 2018. The composite is managed in comparison to, not duplication of the benchmark. The composite inception date is 1/1/2014. The composite was created in January 2014.
- The ICE Bank of America Merrill Lynch 1-10 Year U.S. Municipal Securities Index is an unmanaged index that is a subset of the ICE Bank of America Merrill Lynch U.S. Municipal Securities Index including all securities with a remaining term to final maturity less than 10 years. For comparison purposes the index is fully invested, which includes the reinvestment of income. The returns for the index do not include any transaction costs, management fees or other costs.

## Definitions

**Beta** (cash adjusted) is a measure of relative risk and the slope of regression.

**Information Ratio** measures the risk-adjusted returns of a financial asset or portfolio relative to a certain benchmark.

**Sharpe Ratio** is a risk-adjusted measure calculated using standard deviation and excess return to determine reward per unit of risk. A higher Sharpe ratio indicates better risk-adjusted performance.

**Standard Deviation** measures a fund's range of total returns and identifies the spread of a fund's short-term fluctuations.

**Tracking Error** is defined as the expected standard deviation of a portfolio's excess returns over the benchmark index return.
