The 30-day taxable-equivalent SEC yield represents the tax-adjusted 30-day SEC yield for investors in the highest individual marginal federal income tax bracket (35%). Had fees not been waived and/or expenses reimbursed, the SEC yields would have been 1.37% for Class A shares, 0.67% for Class C shares and 1.66% for Class Y shares. The 30-day taxable-equivalent SEC yields would have been 2.33% for Class A shares, 1.15% for Class C shares and 2.82% for Class Y shares.

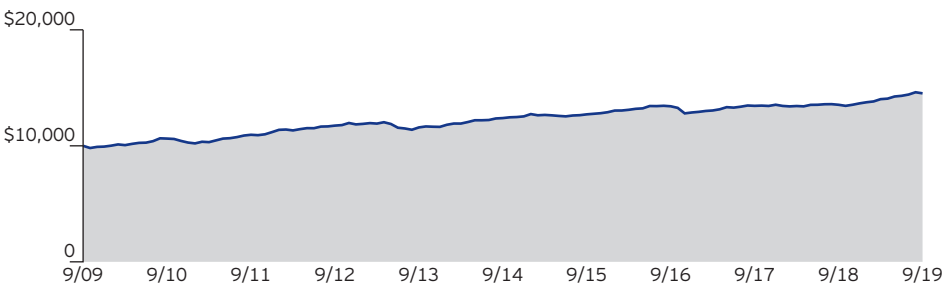

The overall rating is derived from a weighted average of three-, five- and 10-year rating metrics, as applicable, excluding sales charges and including fees and expenses. Had fees not been waived and/or expenses reimbursed currently or in the past, the Morningstar rating would have been lower. Class A shares received 4 stars for the overall, 4 stars for the three years, 4 stars for the five years and 4 stars for the 10 years. The fund was rated among 244, 244, 217 and 149 funds within the Morningstar Muni National Intermediate Category for the overall period, three, five and 10 years, respectively.
