

# Invesco U.S. Treasury Ladder, 1-5 Year SMA

## Why invest in this strategy

- 1 Predictable income**  
 Using a laddered structure, regular coupon payments with different maturity dates can provide a predictable fixed income stream.
- 2 Interest rate diversification**  
 The strategy focuses on minimizing interest rate risk by reinvesting maturing short-term bond proceeds into securities with different yield profiles.
- 3 Technology automation**  
 Technology fuels our efficient, scalable portfolio management process; this leads to faster, more seamless trade execution.

## What this strategy does

This strategy invests entirely in U.S. Treasury securities with individual bonds maturing quarterly within the overnight to 5-year range. Bonds are held to maturity and proceeds are reinvested into the longest maturity of the ladder. The strategy is designed to provide predictable income and interest rate diversification.

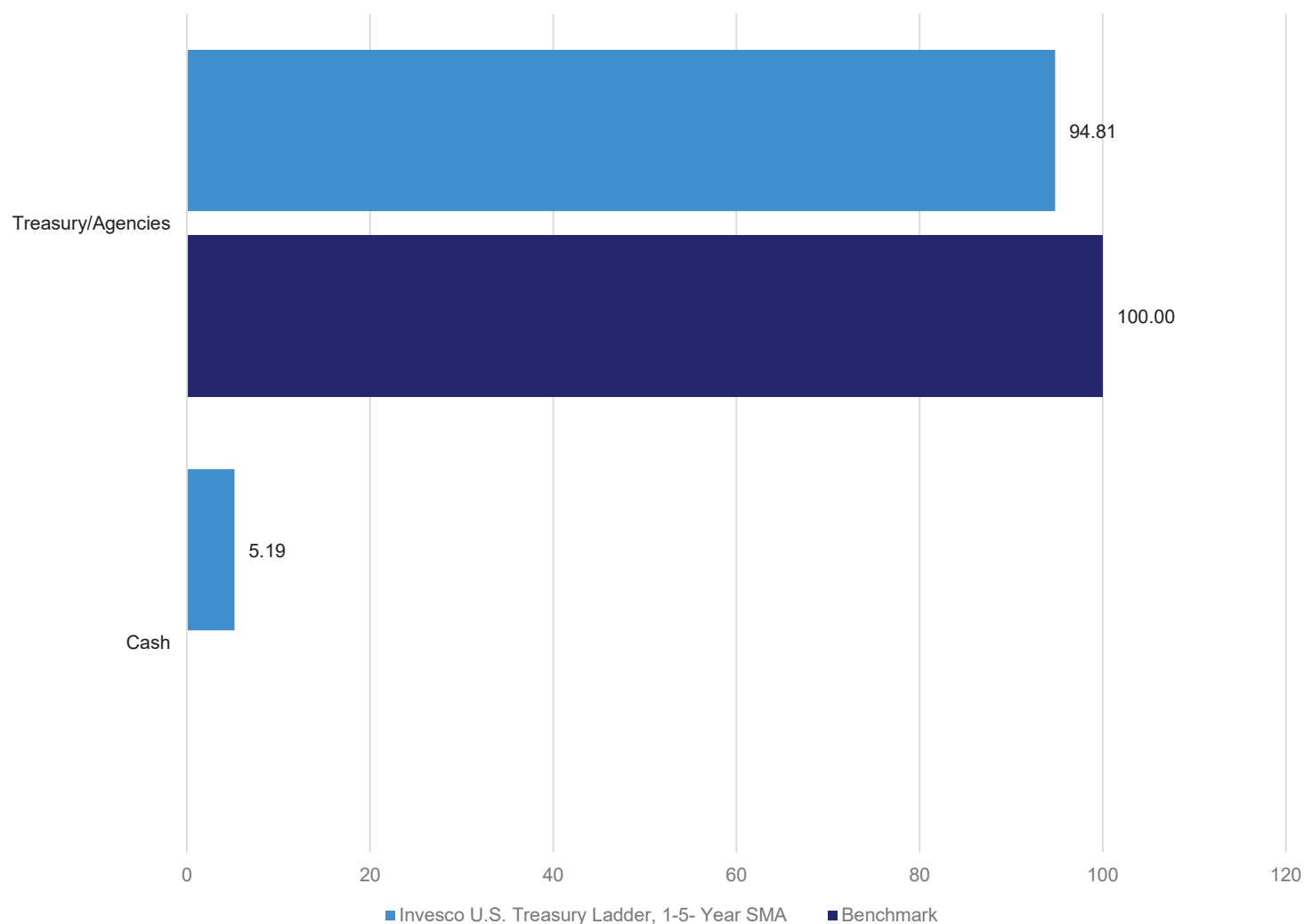

- The Invesco U.S. Treasury Ladder 1-5 Year SMA Composite includes every fully representative portfolio managed in the strategy. The composite includes portfolios that seeks to provide clients with exposure to the U.S. Treasury market via a laddered portfolio structure, where individual holdings are equal weighted across the stated maturity range. Proceeds from interest payments and maturities are reinvested into the longest maturity of the ladder. For the 1-5 year strategy, there will be maturities each quarter. All portfolios included in the composite are actively managed. The composite is managed in comparison to, not duplication of the benchmark. The composite inception date was 7/31/2023. The composite was created in August 2023.
- ICE BofA 1-5 Year US Treasury Index is a subset of ICE BofA US Treasury Index including all securities with a remaining term to final maturity less than 5 years. ICE BofA US Treasury Index tracks the performance of US dollar denominated sovereign debt publicly issued by the US government in its domestic market. Qualifying securities must have at least one year remaining term to final maturity, a fixed coupon schedule and a minimum amount outstanding of \$1 billion. Qualifying securities must have at least 18 months to final maturity at the time of issuance. For comparison purposes the index is fully invested, which includes the reinvestment of income. Effective July 2022, the benchmark returns reflect the deduction of transaction costs that are calculated using the bid/offer spread for all new additions to the index, as well as any security whose weight increases in the index at each monthly rebalancing, beginning with the 30 June 2022 rebalancing. The beginning-of-month calculated transaction cost adjustment is applied to index returns daily for the following calendar month. Benchmark returns prior to July 2022 do not reflect the deduction of transaction costs.
- The Composite gross-of-fee returns reflect the reinvestment of income and the impact of transaction costs, but do not include the deduction of investment advisory fees, distribution expenses or any other account expenses, such as custodial fees. Composite net-of-fee returns are calculated by deducting actual management fees from the underlying portfolios' gross returns. Annual fees for the Invesco U.S. Treasury Ladder 1-5 Year SMA product range up to 0.25% of the market value of the assets under management. Actual fees may vary depending on, among other things, the vehicle type, applicable fee schedule and portfolio size.
- The dispersion of annual returns is measured by the equal-weighted standard deviation of account returns included in the composite for the full year. For periods with five or fewer accounts included for the entire year, dispersion is not presented as it is not considered meaningful.
- The three-year annualized ex-post standard deviation measures the variability of the monthly returns of the composite and the benchmark over the preceding 36 months. The standard deviation is not presented where there is less than 36 months of performance history.
