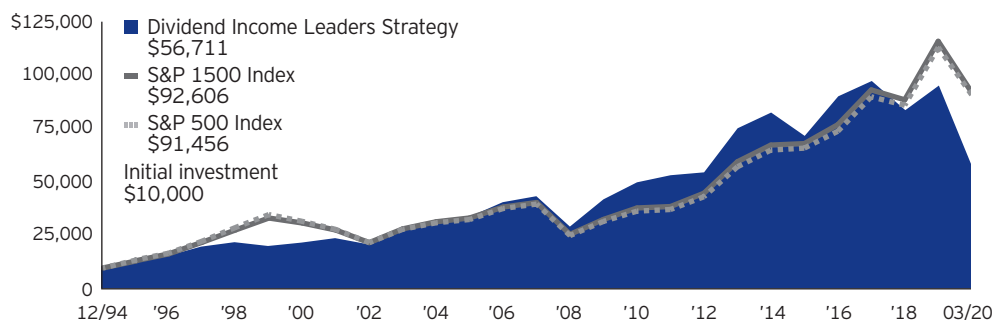

### Objective

The Portfolio seeks to provide current income and the potential for capital appreciation by using an enhanced index strategy\* to select an equally weighted portfolio of 33 dividend paying stocks derived from each sector of the S&P 1500<sup>®</sup> Index. The selection process seeks to identify the top dividend yielding stocks across the primary market sectors.

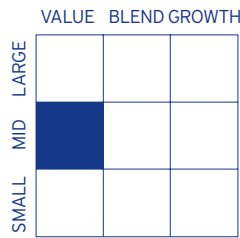

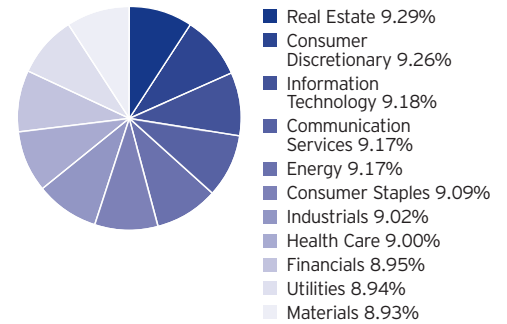

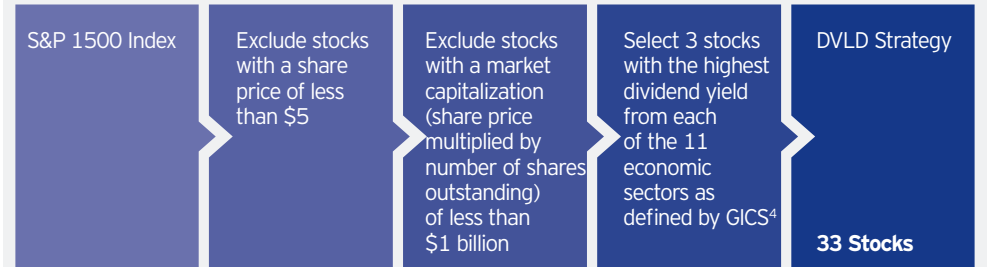
