These portfolios provide customized municipal bond portfolios tailored to specific maturity profiles, risk preferences, and investment goals. The portfolios are designed to be evergreen across four maturity bands: 0–3, 0–5, 0–7, and 0–10 tax-free years.

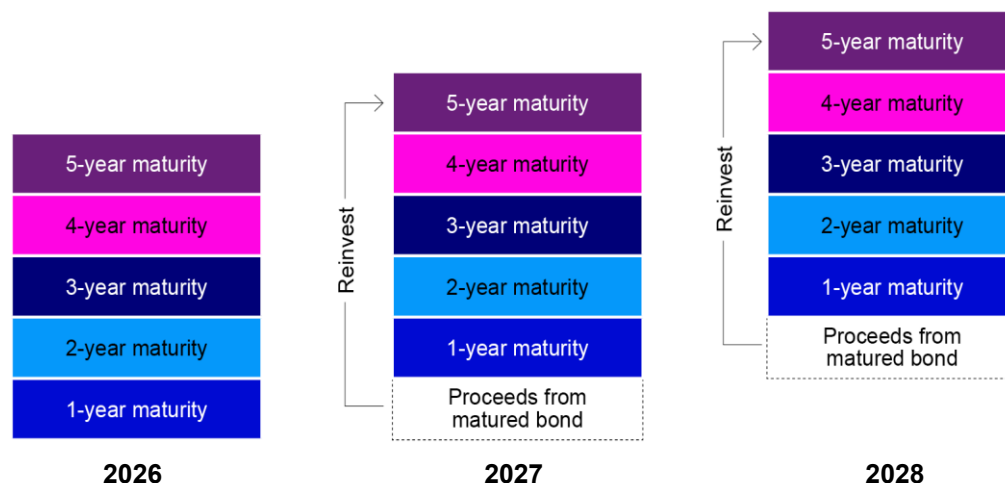

Invesco may rebalance the portfolio on a more frequent basis than noted if necessary due to changing market conditions.

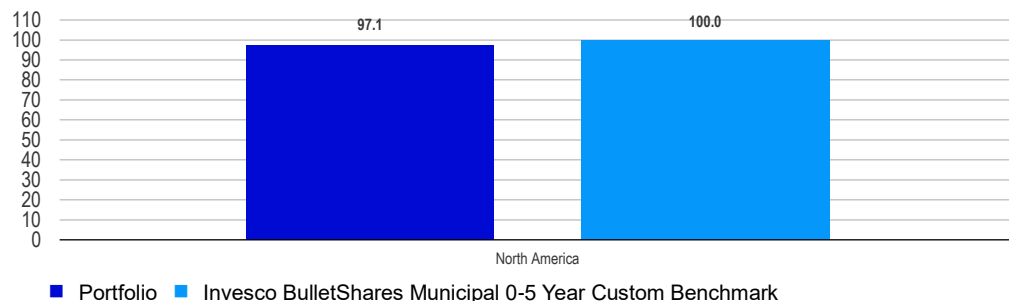

The Invesco BulletShares Municipal 0-5 Year Wrap Composite includes all discretionary accounts styled after the Invesco BulletShares Municipal 0-5 Year Model Portfolio. The portfolio seeks to track the investment results (before fees and expenses) of the appropriate broad-based market indexes that represent the duration and style of the relative BulletShares. For periods beginning June 1, 2024, the composite is composed of 100% non-fee paying discretionary wrap accounts. Prior to June 1, 2024, the composite was composed of 100% non-fee paying discretionary institutional accounts. The historical performance results are those of the Invesco BulletShares Municipal 0-5 Year Institutional Composite. The composite is managed in comparison to, not duplication of, the benchmark. The composite was created in January 2020.

The Invesco BulletShares® Municipal 0-5 Year Custom Index is a combination of the Invesco BulletShares® Municipal 0-5 Year Custom Index (thru 12/31/2021) and the Bloomberg Municipal Bond 1-5 Year Total Return (TR) Index Unhedged USD. The Invesco BulletShares® Municipal 0-5 Year Custom Index (thru 12/31/2021) was used solely prior to January 1, 2022, and Bloomberg Municipal Bond 1-5 Year TR Index Unhedged USD is used thereafter. The benchmark was changed to broad-based market indexes that better represent the duration and style of the relative BulletShares portfolio, either corporate or municipal. The Invesco BulletShares® Municipal 0-5 Year Custom Index (thru 12/31/2021) is comprised of 19.6% of the Invesco BulletShares® USD Municipal Bond 2021 Index, 19.6% of the Invesco BulletShares® USD Municipal Bond 2022 Index, 19.6% of the Invesco BulletShares® USD Municipal Bond 2023 Index, 19.6% of the Invesco BulletShares® USD Municipal Bond 2024 Index, 19.6% of the Invesco BulletShares® USD Municipal Bond 2025 Index, and 2% of the Lipper 3 Month T-Bill Index. The BulletShares® Indexes are designed to provide maturity-targeted exposure to the US dollar-denominated investment grade municipal bond market. Each Index tracks a diversified basket of bonds with the same annual maturity and is designed to have a return profile similar to that of an individual held-to-maturity bond. The Lipper 3 Month T-Bill Index is designed to provide performance for the three-month US Treasury bill. The Bloomberg Municipal Bond 1-5 Year TR Index Unhedged measures the USD denominated, fixed rate, tax exempt bond market with a maturity between 1-5 years. The benchmark is used for comparative purposes only and generally reflects the risk or investment style of the product. The custom index is rebalanced daily. For comparison purposes the index is fully invested, which includes the reinvestment of income. The returns for the index do not include any transaction costs, management fees or other costs.

"Pure" gross of fees returns reflect the deduction of trading costs but do not reflect any other expenses, outside of the operational expenses, and are supplemental to net returns. Performance results are presented both net and gross of total wrap fees. For periods beginning March 1, 2024, the net returns reflect the deduction of the maximum total wrap fee, which is currently 3.00% per annum or 0.250% monthly, from the "pure" gross return. For periods from March 1, 2021 through February 29, 2024, the net returns reflect the deduction of the maximum total wrap fee of 1.50% per annum or 0.125% monthly, from the "pure" gross return. Prior to March 1, 2021, the net returns reflect the deduction of the maximum total wrap fee of 2.00% per annum or 0.1667% monthly, from the "pure" gross return. Effective March 1, 2024, the model fee has been retroactively changed for all periods since inception to 3.00%. A model fee is the highest wrap fee a client could pay (3.00% annually as charged by the program sponsor). The total wrap fee includes all charges for trading costs, portfolio management, custody and other administrative fees. The standard wrap fee schedule currently in effect is as follows: 3.00% on total assets. Actual fees may vary depending on, among other things, the applicable fee schedule and portfolio size. The dispersion of annual "pure" gross returns is measured by the equal-weighted standard deviation of account's "pure" gross returns included in the composite for the full year. For periods with five or fewer accounts included for the entire year, dispersion is not presented as it is not considered meaningful. The three-year annualized ex post standard deviation measures the variability of the monthly "pure" gross returns of the composite and the benchmark over the preceding 36 months. The standard deviation is not presented where there is less than 36 months of performance history. Past performance is not indicative of future results.
