American Jobs Creation Act Qualified Interest Income (QII) Percentages for the Funds based on their year end 1099s.

Certain Funds generate qualified interest income and short-term capital gains that may be exempt from United States withholding tax when distributed to non-U.S. holders. The U.S. tax law permits a regulated investment company ("RIC") to designate the portion of distributions paid that represent interest-related dividends (commonly referred to as qualified interest income) and short-term capital gain dividends as exempt from U.S. withholding tax when paid to non-U.S. shareholders with proper documentation. The distributions that have been identified by the Funds as exempt from U.S. withholding tax are disclosed in the table below.
