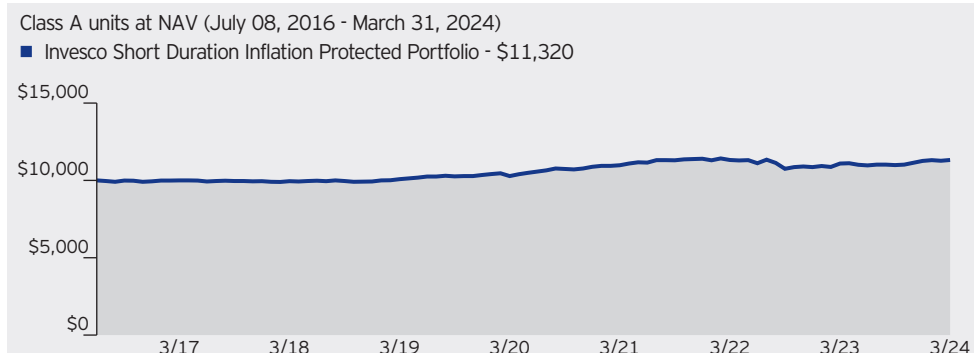

It takes into account mortgage prepayments, puts, adjustable coupons and potential call dates.

#### About risk

##### Risks of the Underlying Holding
