Notice of the Sources of Fund Distribution

Form 1099-DIV for the calendar year will report distributions for US federal income tax purposes. This distribution, determined in accordance with generally accepted accounting principles, is estimated to be from the following sources: (1) \$0.2448(Series I), \$0.2076(Series II) per share from net investment income; (2) \$0.2094 per share gain from sale of securities; and (3) \$0.0560(Series I), \$0.0560(Series II) per share from return of principal.
