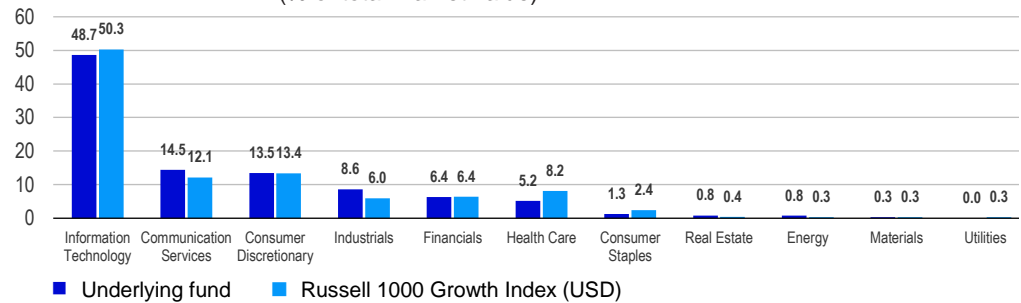
## What this portfolio does

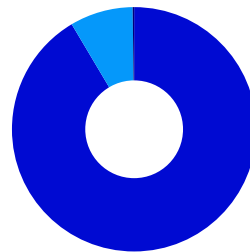

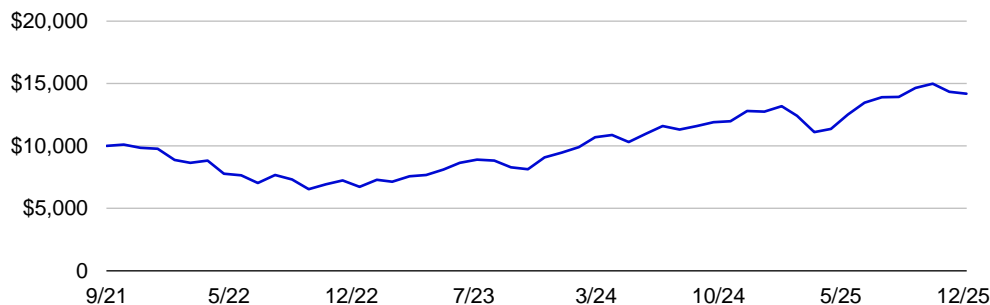
