

## 2024 Dividends Received Deductions

Dividends Received Deduction (DRD) and Business Interest Income (BII) for the period ending December 31, 2024.

- Below are the percentages of 2024 fund dividends which are eligible for the corporate dividends received deduction. In order to utilize the deduction, a corporate shareholder must meet other requirements including satisfying a holding period rule. Also below are the percentages of fund dividends which qualify as business interest income. A shareholder that receives a section 163(j) interest dividend may treat the dividend as interest income for purposes of section 163(j), subject to holding period requirements and other limitations. Please note that these percentages are given as a percentage of the ordinary dividend (income plus short-term capital gain) rather than the income dividend.
- To calculate the dividends which are qualified for the corporate dividends received deduction, apply these percentages to the ordinary dividend (not the income dividend), i.e., the income and the short-term gain distributions.
